Qualifications

This contest is open to any angler who is a financial member of the Game Fishing Club Of Northern Tasmania.

Fishing Rules

Shall be the current rules of the Game Fishing Club Of Northern Tasmania and TGFA.

Fishing Times

12.00 midnight 1st July 2019 to 12.00 midnight 30th June 2020

Weigh-In

All fish are to be weighed in by an Weighmaster.

Control

Contest will be under the sole control of the contest committee and any decisions will be final and binding

Line Class and Minimum Weight

This Tournament is not a 'line class' competition but line must be a GFAA approved class. NOTE: Normal club and TGFA minimum fish weights still apply (see GFCNT 'Competition Rules and Safety Details')

Safety

Boats must be equipped with the minimum safety equipment as specified by

M.A.S.T. Radio schedules will be conducted by the Base Station at St Helens Marine Rescue at ten minutes past every other hour, from 7.10am on VHF Channel 16 during daylight hours. If fishing at night, arrange suitable check-in times with either the base or another boat.

Lee-Way Allowance

All competitors to allow at least 500m lee way for any boat fighting a fish. (Unless required to assist).

Trophies

1st and 2nd Heaviest Game Fish (Sharks and Broadbill exempt)

Entries

There must be a minimum of one Tournament Entrant on each boat and at least one G.F.A.A, TGFA member.

Cost is \$10.00 per angler for the twelve (12) months.

Fishing Boundaries

Northern Boundary: Centre of Banks Straight--40'37 000

Southern Boundary: 2 NM South of Schouten Island-42'23000
